## THRONE SPEECH KEEPS PROMISES AND MOVES SASKATCHEWAN FORWARD

The 2011 Throne Speech kicked off the opening of the first session of the 27th Legislature by outlining a plan to fulfill election commitments while living within our means and keeping the province moving forward.

Premier Brad Wall said the Throne Speech shows the government's plan to keep the commitments it made in the recent election campaign. The Throne Speech listed seventeen promises that will be kept in this session. Here are a few samples:

- continued economic and population growth
- further improvements to Saskatchewan's highways
- improving the availability and affordability of housing
- introducing a new Saskatchewan First-Time Homebuyers Tax Credit
- extending the Active Families Benefit to all children under 18
- increasing support for autism
- continuing to reduce surgical wait times; and
- improving access to health care services in rural communities

"These measures will keep our province moving forward and will make life more affordable for Saskatchewan people," Wall said. "Most importantly, they are sustainable and will be achieved within a balanced budget."

## **HUGE INCREASE IN SASKATCHEWAN EXPORTS**

Merchandise exports in the province took a huge jump in October according to a report released today by Statistics Canada. Merchandise exports increased by 53.6 per cent over October of 2010, well ahead of the 13.9 per cent rise nationally. Saskatchewan ranked first among the provinces in terms of percentage change.

"Trade is an important factor in attracting new investment and new people to our province," Enterprise Minister Jeremy Harrison said. "The Saskatchewan brand is gaining momentum on a global front and it means more opportunities for families and businesses in the future."

## **BUILDING PERMITS TEN TIMES HIGHER THAN NATIONAL AVERAGE**

Construction continues to rise at a rapid pace according to the October building permit statistics released today by Statistics Canada.

Saskatchewan's building permits are up by 22.4 per cent in October 2011 over October 2010, ten times higher than the national average of 2.2 per cent and the highest increase among the provinces.

"Our economy is growing at a rate that is the envy of many other jurisdictions due to strong expansion in the resource sector and a growing population," Enterprise Minister Jeremy Harrison said. "Saskatchewan is showing the rest of the world that we have an advantage in our province that maximizes both personal and business opportunities, while we continue steady, reliable fiscal management."

## **ONLINE HEALTH CARD APPLICATION SERVICE EXPANDED**

Saskatchewan's online Health Services Card application service has been expanded to other categories of new residents, including foreign nationals and returning Canadian citizens.

After the service expansion, all new Saskatchewan residents living in the province are eligible to use the online application process.

"We are very pleased to provide a more convenient health benefits registration experience to our new residents," Health Minister Don McMorris said. "Phase one of the integrated online service has been well received by the public. We now feel very confident in extending our online service to better serve even more new residents in the province. This is another example of how we are putting the patient first."

## ENHANCED SUPPORT FOR PEOPLE WITH DIABETES

#### Campaign Promise Improves Quality of Life

Saskatchewan is following through on its commitment to provide more support for people with diabetes. Health Minister Don McMorris announced today the government is meeting its election commitment to move two long-acting insulins from Exception Drug Status listing to full formulary listing, and expand the insulin pump program to cover residents up to the age of 25.

"Diabetes is a serious disease affecting a growing number of residents in our province," McMorris said. "These two measures will realize significant cost savings for families affected by the disease. The enhancements also help individuals with diabetes to better manage their conditions and make real progress in improving their quality of life. This is another way our government is putting patients first."

## JUSTICE MINISTER INTRODUCES MOTION TO STUDY PROVINCIAL LOBBYIST LEGISLATION

At the request of Premier Brad Wall, Justice Minister and Attorney General Don Morgan today introduced a motion to refer the issue of lobbyist legislation to the Standing Committee on Intergovernmental Affairs and Justice for review and to report back to the Legislative Assembly.

With the large increase in economic activity in Saskatchewan over the past several years, it was recognized that paid lobbyists may seek to play a greater role in the province.

"Lobbying public office holders is a legitimate activity when done appropriately," Morgan said. "This legislation must strike a balance between free and open access to government decision makers by legitimate lobbyists, and the public's need to know who is attempting to influence the government."

## DID YOU KNOW

- Our population is now at an all-time high: 1,057,884. It has grown by 13,856 people in the past year, making Saskatchewan the third-fastest growing province in Canada (+1.33 per cent). The province's population has now increased for 21 consecutive quarters, and in the past five years, Saskatchewan has grown by over 65,000 people the fastest and most sustained period of population growth in decades.
- New employment numbers show that 524,200 people were employed in November 2011, the second-highest level of employment on record for the month of November. There were employment increases in construction, retail and wholesale trade, finance, insurance and real estate, services, and public administration.
- Saskatchewan's unemployment rate (seasonally-unadjusted) now stands at 4.7 per cent, the lowest rate in Canada and well below the national rate of 7.0 per cent. (Note: The seasonally-adjusted rate is 5.1 per cent, the second-lowest rate in Canada and also below the national rate of 7.4 per cent).
